ORDER

On this 7th day of August, 2026, this matter came on for hearing on *Plaintiff's Motion for Sanctions against Uber Technologies, Inc.* Attorneys Clark O. Brewster, Guy A. Fortney, and Katie A. McDaniel appeared for Plaintiff; Mark Hardin and Hailey Hopper appeared for Defendant Uber Technologies, Inc.; and Stephen Coates (via Microsoft Teams) for Defendant Ba-Abbad. The Court finds as follows:

- A. The decision on *Plaintiff's Motion for Sanctions* is taken under advisement until trial in this matter. *at Plaintiff's Request; Plaintiff may Renew the motion post-trial upon application; MAZ*
- B. Within ~~thirty (30)~~ *thirty-five (45)* days of this Order Defendant Uber shall produce a corporate representative(s) for further deposition discovery pursuant to 12 O.S. § 3230. *MAZ*
- C. Within ~~twenty-one (21)~~ *thirty (30)* days of this Order Defendant Uber shall produce the following documents: *MAZ*
1. Drivers Safety Lens for Omar Emran Ba-Abbad, including all JIRA and Bliss communications referenced therein;
 2. All JIRAs related to Omar Emran Ba-Abbad;

3. Chronical and Voyager data associated with Omar Emran Ba-Abbad on June 25, 2020 and June 26, 2020;
4. Documents regarding Omar Emran Ba-Abbad's appeal of deactivation from Uber Eats;
5. The Status and Flow regarding Omar Emran Ba-Abbad's access and use of Uber and Uber Eats, including all available data columns under the software options;
6. The Mobile Events data for Omar Emran Ba-Abbad, including all available data columns under the software options;
7. All Bliss communications regarding Omar Emran Ba-Abbad, including all available data columns under the software options;
8. Policies and procedures, including Knowledge Base ("KB") documents, regarding investigations of passenger complaints, safety incidents, and deactivations of drivers and Uber Eats partners, including DACT policies, from 2018 through July 2020; and
9. All insurance policies under which an insurer may be liable to satisfy all or part of a potential judgment or to indemnify or reimburse payments made to satisfy a judgment pursuant to 12 O.S. § 3226.

IT IS ORDERED, ADJUDGED AND DECREED.

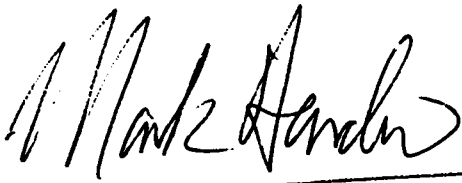

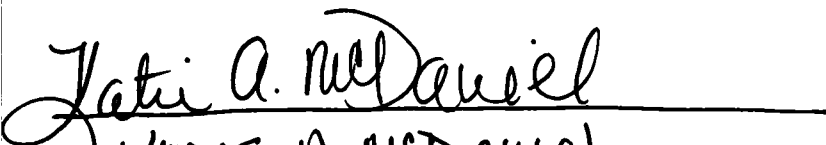
